Subject:	Proposals under the ordinary legislative procedure expected to undergo the Corrigendum Procedure in the European Parliament (part I)

- 1. In accordance with the provisions of Article 294 of the TFEU and the Joint Declaration on practical arrangements for the co-decision procedure¹, a number of informal contacts have taken place between the Council, the European Parliament (EP) and the Commission with a view to reaching an agreement at first reading on a series of proposals under the ordinary legislative procedure (OLP).
- 2. After analysis and confirmation of the provisional agreements by Coreper, the EP has adopted its first reading position, without legal-linguistic revision, on these proposals before the end of the 9th legislative term.
- 3. Once the legal-linguistic experts have revised the texts, the Corrigendum Procedure² will allow the Plenary of the incoming EP to approve as a corrigendum the legally revised text of its first reading positions.
- 4. If the EP Plenary approves the corrigenda, the Council should be able to approve the position of the EP on that basis, thus bringing to a close the first reading for both institutions.
- 5. The acts would then be adopted in the wording which corresponds to the Parliament's position.
